

# Rules and Responsibilities of an Emotional Support Animal

**Emotional Support Animal Approval Process**

A student who will keep ESA in University housing is needed to make a formal request by submitting an emotional support animal certification or letter from a licensed psychological wellness care professional. There must be a reasonable and recognizable established relationship between the disability of an individual and the support the ESA provides. A letter must contain information distinguishing a diagnosed mental disability and the reason ESA is required. You can also check the [esa letter](#) for housing sample online to know what the letter resembles. All documentation will be surveyed for endorsement by the University Director and the student will be informed with regards to the decision by email by the Residence Life Office. The Residence life Office is responsible to ensure that individuals with mental disabilities who use ESA get the advantage of the ESA under the Federal Laws. After this process, the individual is needed to submit all documents of ESA wellbeing and inoculation.

### **Care and Supervision**

Under the residential strategy section, the care and supervision of an ESA are solely the responsibility of a proprietor. An ESA must stay in secretly assigned living convenience (condo or room) of a person but to the degree that an individual is taking an ESA out for a walk, exercise, and normal help. - The ESA should not be left for the time being in a condo under the supervision of some other person other than the proprietor.
- The ESA proprietor must give the contact number of some other caregiver in case of emergencies such as mishap or hospitalization.
- The proprietor of an ESA must conform to every one of the laws with respect to keeping an ESA and is responsible to ensure that ESA is polite and won't disrupt the residential local area.
- The ESA must be immunized every year and all documents must be submitted to the Residence life Office every year.

### **Waste Management and Cleaning**

The proprietor of an ESA is responsible for dealing with all tasks identified with cleaning and really focusing on an ESA such as litter and bedding, waste administration, hair/hide, and so forth Solid waste needs to be disposed of in a designated dumpster. Try not to fear your landlords, in case you are possessing an esa letter.

### **ESA Behavior**

The proprietor of an ESA must follow every one of the relevant laws identified with the keeping of an animal. The ESA proprietor should ensure that ESA won't pose any immediate threat to the safety and strength of any singular living in the same residential office. If you have a pet you should know about an [esa letter for housing](#). The ESA must not cause any harm to physical property. In this case, the proprietor can be charged for any harm or ESA can be rejected from the residential office and the executives won't be responsible. Infringement of any of the above conditions can result in the accompanying activity by the Residence Life Office.

### **Composed or Verbal Warning**

Evacuation of an ESA inside 7 days of a composed notice. Inability to conform to the evacuation request can result in an infringement of the student set of accepted rules. Notwithstanding, the ESA proprietor might pursue the decision to recover the animal.

- Charging the person for cleaning, damages, freshening up and pest control
- Evacuation of an ESA inside 24 hours for threatening and aggressive conduct.

### **Inspection**

The residence of an ESA proprietor can be inspected for ticks, fleas, or pests whenever. The inspection is scheduled by the Office of Residential Life and residence is informed ahead of the scheduled inspection. In the event that pests, ticks, or fleas are identified during inspection the ESA proprietor will be charged for the necessary pest control treatment.
